The amount (1) shown reflects .709 shares acquired pursuant to the Cleveland-Cliffs Inc Dividend Reinvestment Plan. The number also includes 6.734 shares of Restricted Stock acquired June 1, 2005 pursuant to a dividend reinvestment feature of the Nonemployee Directors' Compensation Plan ("Plan").
